• MDT

- Preschool children
- Significant hearing loss bilateral hearing loss of a level greater than 40db in the better ear (NBHS Wales 2012)
- Every 6 months
- Appointments are 45 minutes per child
- Aim of the meeting is to prepare a Multi Agency Support plan (MASP).

Date of Early Years Hearing Meeting:

Present: Child, parents, grandmothers; Anne Thomas, Audiology; Liz Rees, Speech Therapist; Jo Plant – Teacher of the Deaf, Portage worker, Dr V Hickson Paediatrician

Parent Report: Child is now wearing his aids for up to 2 hours at a time and does not cry when they are inserted. He is progressing well and is copying tones of songs and speech, although not saying the words. He may be saying "hiya" into the phone.
He goes and gets what he wants eg will bring his bottle if he wants a drink.
Assessment suggests delayed development but Mum feels he was tired when assessed and can do more than he did that day. It is difficult to sign with him as he does not make eye contact well.
He is no longer using a dummy.
His grandmothers feel that his development has vastly improved. He gets very involved in play eg using stacking cups, likes books, and says "oof oof" for dog.

Audiology Summary: Child's hearing was last assessed on 23/06/14. He did not tolerate his ear moulds so he was tested using sound field audiometry which indicated a moderate hearing loss in his better hearing ear. Tympanograms were mobile.

He has been seen twice since then for reprogramming of his aids and aided tests. Predictive real ear measures were used as he does not tolerate the tube, and aided thresholds were normal after adjustment for high pitches. The maximum power output of the aids has been reduced slightly as Dad felt he was finding loud noises uncomfortable.

He is due for reassessment in March 2015.

Medical Summary:

Saw Dr on 27/11/14. Assessment indicated development below average for his age and recommendation for multi therapy input to help maximise his developmental potential.

Saw Dr on 03/10/14 and continues on Sodium Valproate for epilepsy. He is due a further appointment in 4-5 months.

Education Summary: Child receives monthly support sessions from the HI Service, Targets are focussing on encouraging increased use of hearing aids, and encouraging eye control and vocalisation through play. Child will wear his hearing aids when he is distracted.

Speech Therapy Summary: Liz Rees is due to visit the family on 20th January with portage. Liz to give advice and strategies about developing Child's communication. Parents are happy that they can interpret his needs at home. Liz explained that nursery staff will find it more difficult to interpret his needs so we want to help him develop his communication so that he is able to communicate what he wants to others. Liz to discuss with parents about increasing the frequency of visits at the appointment on January 20th.

Portage Summary: Child is making progress now and is much more interactive than he was. He is more interested and involved in play, and he had a spurt in development after his operation.

Portage visited yesterday and Child kept his hearing aids in while she was there. He joined in with shared play, lifting the flaps in a book, copying, initiating a social game of "boo", making sounds with cars, matching objects to pictures, and making more eye contact than previously. His self help and gross motor skills have progressed and he is trying to wash and feed himself. His developmental profile is now at a 2 year level, but there are gaps in his cognitive development which can be linked to language.

- NBHSW pathway
- Evidence proves MDT working is effective
 - time and resources
 - families don't have to repeat information
 - care plans reflect the current needs of the child or young person and their family

- increases the family's confidence in the support offered and reduces anxiety.




